BALLOT MEASURES

The below ballot measure descriptions are listed as an informational resource. View the official LA City voter information pamphlet with ballot summaries and details [here](#).

STATE

Proposition 1

Prohibits state from denying or interfering with an individual's right to choose an abortion or contraceptives.

Proposition 26

Allows in-person sports wagering for tribal casinos and the state's four horse race tracks.

Proposition 27

Allows online sports wagering for licensed tribes and gaming companies to 21+ adults outside tribal lands.

***Proposition 28**

Guarantees minimum funding for arts and music in schools.

Proposition 29

Requires dialysis clinics to have certain medical professionals on site and increase data reporting to the state.

Proposition 30

Funds programs to reduce air pollution and prevent wildfires via an increased tax on personal income over \$2 million.

Proposition 31

Prohibits the sale of certain flavored tobacco and harm reduction products.

LA COUNTY

Measure A

Allows the LA County Board of Supervisors, by a four-fifths vote, to remove the sheriff from office.

Measure C

Enacts taxes on marijuana businesses in unincorporated areas of LA County.

COMMUNITY COLLEGE DISTRICT

Proposition LA

Authorizes district to issue \$5.3 billion in bonds to fund facility renovations and job training programs and tax \$25 per \$100,000 of assessed value to repay bonds.

LA CITY

*Proposition LH

Authorizes public entities in the City to develop, construct or acquire 5,000 more low-income rental units in each council district.

Proposition SP

Funds the construction, operations and maintenance of parks and recreational facilities across the city via a parcel tax.

Ordinance ULA

Imposes a tax on the sale or transfer of real property valued at over \$5 million to fund affordable housing and tenant assistance programs.

WHEN & WHERE TO VOTE

Once you receive your ballot and drop boxes and/or vote centers open, voting begins! November 8, California General Election Day, is the last day to vote.
